

**RESOLUTION NUMBER R18-001**

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF SAFFORD  
EXPRESSING INTENT TO AMEND AND INCREASE WATER FEES PURSUANT TO  
ARIZONA REVISED STATUTES §9-511.01 AND SETTING PUBLIC HEARING.**

**WHEREAS**, The City of Safford owns, operates and provides water utility services for the benefit of the property owners within and without the City's corporate boundaries pursuant to the provisions of *Arizona Revised Statutes* §9-511, et. Seq.; and,


**WHEREAS**, the Mayor and City Council, when considering an increase to any rate or rate component, fee or service charge for utility services, shall adopt a Notice of Intention complying with the provisions of *Arizona Revised Statutes* §9-511.01, and §9-499.15; and,

**WHEREAS**, in accordance with *Arizona Revised Statutes* §9-511.01, the City has prepared written reports supplying data supporting the proposed new fees for water utility services prepared by K.R. Saline and Associates.


**NOW THEREFORE BE IT RESOLVED**, by the Mayor and City Council of the City of Safford, Graham County, Arizona, as follows:

1. This Resolution shall serve as a written Notice of Intention to the public that the City of Safford intends to adopt new fees for water utility services; and,
2. Notice shall also be published in a newspaper of general circulation within the City of Safford as required by *Arizona Revised Statutes* §9-511.01 and shall be posted on the City website as required by *Arizona Revised Statutes* §9-499.15; and,
3. A public hearing on the proposed new capacity fees for water utility services shall be held during the regular City Council meeting at 6:00 p.m. on March 12, 2018 at the Safford Library Program Room, located at 808 S 7<sup>th</sup> Avenue, Safford, Arizona.
