

RESOLUTION NUMBER R18-024

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF SAFFORD, GRAHAM COUNTY, ARIZONA AMENDING THE PER DIEM TO BE PAID TO MEMBERS OF THE COUNCIL.

WHEREAS, by Ordinance 07-006 passed on the 23rd day of July 2007 with an effective date of July 2008, the Council authorized the payment of a per diem in the amount of \$30.00 on criteria to be established by resolution for services rendered the City by members of the Council, and

WHEREAS, ~~a committee has recommended criteria for the per diem payment, and the council desires to amend the criteria to qualify for the per diem.~~


~~WHEREAS, the council desires to adopt the recommendations of the committee.~~

NOW THEREFORE BE IT RESOLVED, by the Mayor and City Council of the City of Safford, that in addition to reimbursable expenses, members of the council shall be paid a per diem in the amount of \$30.00 on the following criteria:

1. \$30.00 for each day the Council member is in fact outside of ~~the local area~~ Graham County on City business. ~~or~~
- ~~2. \$30.00 for each day the Council member participates in Council directed committees, meetings, or activities that require a cumulative total of two or more hours in a day.~~
2. No more than one per diem payment of \$30.00 will be made for services rendered within the same day.
3. A request for per diem payment must be received by the Accounting Department within 30 days of the services rendered.

IT IS FURTHER RESOLVED, that it is the intent that the per diem is not to be paid for meetings or gatherings that are considered to be a part of normal council functions or duties, such as regular Council meetings, special Council meetings, joint meetings of the Council with governing boards of governmental or quasi-governmental agencies, Council work sessions held within the City. It is the intent to pay per diem for special circumstances that require ~~either~~ travel ~~or~~ and time away from home or employment and meets the criteria set forth in this resolution.




