

RESOLUTION NUMBER R18-031

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF SAFFORD, GRAHAM COUNTY, ARIZONA, TO ADOPT THE 2018 GRAHAM COUNTY MULTI-JURISDICTIONAL HAZARD MITIGATION PLAN, WHICH WAS DEVELOPED WITH THE COOPERATION OF GRAHAM COUNTY, THE TOWN OF PIMA, THE CITY OF SAFFORD, AND THE TOWN OF THATCHER.

WHEREAS, Graham County and all the Cities and Towns are political subdivisions of the State of Arizona and are organized under Title 9 and Title 11 of the Arizona Revised Statutes and as such, each of these entities are empowered to formally plan and adopt this Plan; and,

WHEREAS, the purpose of the Plan is to identify natural hazards that impact the various jurisdictions located within Graham County, assess the vulnerability and risk posed by those hazards to community-wide human and structural assets, develop strategies for mitigation of those identified hazards, present future maintenance procedures for the Plan and document the planning process; and,

WHEREAS, Hazard mitigation identifies hazards that threaten communities, determines likely impacts of those hazards, set mitigation goals, and determines, prioritizes, and implements appropriate strategies to lessen impacts; and,


WHEREAS, this plan was prepared pursuant to the requirements of the Disaster Mitigation Action of 2000 and the implementing regulations set forth in the Federal Register which established the requirements that hazard mitigation plans must meet in order to be eligible for certain Federal disaster assistance and hazard mitigation funding under the Robert T. Stafford Disaster Relief and Emergency Act; and,

WHEREAS, this plan is a multi-jurisdictional plan that geographically covers the participating communities within the Graham County boundaries.

NOW THEREFORE, BE IT RESOLVED, by the Mayor and City Council of the City of Safford, Arizona, do hereby adopts the 2018 Graham County Multi-Jurisdictional Hazard Mitigation Plan.




