

**RESOLUTION NUMBER R19-007**

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF SAFFORD, GRAHAM COUNTY, ARIZONA AUTHORIZING THE MAYOR TO ENTER INTO AN AGREEMENT WITH THE ARIZONA DEPARTMENT OF TRANSPORTATION TO SECURE FEDERAL FUNDS FOR THE IMPROVEMENTS OF 20TH AVENUE FROM RELATION STREET TO GOLF COURSE ROAD.**

**WHEREAS**, the State is empowered by A.R.S. § 28-401 to enter into this agreement; and,

**WHEREAS**, the City is empowered by A.R.S. § 48-572 to enter into this Agreement, resolves to enter into this Agreement and has authorized the undersigned to execute this Agreement on behalf of the City; and,

**WHEREAS** the City of Safford desires to make these improvements to 20th Avenue from Relation Street to Golf Course Road using City and Federal funds for the safety and benefit of the residents of Safford; and,

**WHEREAS**, the City of Safford will provide the required funds (at least 5.7% match) for the improvements and do hereby commit to pay for the cost related to the project development administration; and,

**WHEREAS**, the City of Safford will commit to reimburse to ADOT/FHWA all federal funds used, if the project is canceled by the City; and,

**WHEREAS**, the State shall be the designated agent for the City for the Project; and,

**WHEREAS**, the improvements will reconstruct this street to widen, add curb and gutter, sidewalks, and other incidental or needed structures.

**NOW THEREFORE BE IT RESOLVED**, by the Mayor and City Council of the City of Safford, Arizona does hereby authorize the Mayor to enter into this agreement, designated as IGA/JPA 18-0007192-I, with the State of Arizona for Surface Transportation Program (STP) funds for the improvements along 20th Avenue from Relation Street to Golf Course Road.
