

**RESOLUTION NO. R20-023**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAFFORD, ARIZONA, TO ESTABLISH FEES FOR CITY EMPLOYEE SERVICES AND THE USE OF EQUIPMENT IN CONNECTION WITH SERVICES RELATED TO AUTHORIZED MUNICIPAL ACTIVITY FOR OUTSIDE ENTITIES**

**BE IT RESOLVED BY THE MAYOR AND COMMON COUNCIL OF THE CITY OF SAFFORD, ARIZONA:**

**WHEREAS**, the Council is authorized to establish fees by resolution; and

**WHEREAS**, the Council recognizes the need for employees to provide outside services for other entities in connection with work related to authorized municipal activity, including employee time and equipment time; and

**WHEREAS**, in an effort to achieve recovery of staff costs, it is necessary to establish fees for City employee services to outside entities in connection with work related to authorized municipal activity; and


**WHEREAS**, in an effort to achieve recovery of equipment costs, it is necessary to establish fees for the use of equipment while employees are providing services to outside entities in connection with work related to authorized municipal activity.

**NOW, THEREFORE BE IT RESOLVED** by the Mayor and Council of the City of Safford: the City adopts the following fee for City Employee services:


Section 1. Employee services provided during City of Safford's normal business hours as defined by the City of Safford will be at a rate of \$50 per hour for employee services in connection with work related to authorized municipal activity. Employee services provided outside normal business hours will be at a rate of \$75.


Section 2. The hours equipment is used by City of Safford employees shall be at a rate following FEMA guidelines at the time of service and will be based on the type of equipment used in connection with work related to authorized municipal activity.


