As an alternate to the monthly service charge, the service charges may be prepaid by making a one-time payment to the City of Safford at the time of connection. This one-time payment of the service charge shall be as follows:

As and alternate to full monthly service charges or the one-time prepayment of service charges, the monthly service charge can be reduced by the payment of an up-front amount, in accordance with the schedule below, the up-front payment will be due at the time of connection and the reduced monthly charge will be applicable monthly thereafter. In the case where this up-front payment is made, the monthly service charge shall be as follows:
