

RESOLUTION NO. R21-003

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF SAFFORD, GRAHAM COUNTY, ARIZONA AUTHORIZING THE MAYOR TO EXECUTE AMENDMENT NO. ONE TO THE INTERGOVERNMENTAL AGREEMENT WITH THE ARIZONA DEPARTMENT OF TRANSPORTATION REVISING THE ESTIMATED PROJECT COSTS AND CITY FUNDING RESPONSIBILITIES FOR THE 20TH AVENUE STREET IMPROVEMENT PROJECT FROM RELATION STREET TO GOLF COURSE ROAD.

WHEREAS, the Intergovernmental Agreement, IGA 18-0007192-I, A.G. Contract No. P001 2018 03769, was executed on April 2, 2019, (the "Original Agreement"); and,

WHEREAS, the State is empowered by A.R.S. § 28-401 to enter into this Amendment No. One; and,

WHEREAS, the City is empowered by A.R.S. § 48-572 to enter into this Amendment No. One, and has authorized the undersigned to execute this Amendment No. One on behalf of the City; and,


WHEREAS, the City desires to make these improvements to 20th Avenue from Relation Street to Golf Course Road using City and Federal funds for the safety and benefit of the residents of Safford; and,

WHEREAS, the City of Safford will provide the required funds for the improvements to the State, estimated at \$835,478.00, after completion of design and prior to bid advertisement; and,

WHEREAS, except as amended, all other terms and conditions of the Original Agreement remain in full force and effect.

NOW THEREFORE BE IT RESOLVED, by the Mayor and City Council of the City of Safford, Arizona does hereby authorize the Mayor to execute this Amendment, designated as Amendment No. One to Intergovernmental Agreement, IGA 18-0007192-I, with the State of Arizona for Surface Transportation Program (STP) funds for the improvements along 20th Avenue from Relation Street to Golf Course Road.
