

RESOLUTION NUMBER R21-005

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF SAFFORD AUTHORIZING THE RENEWAL OF THE CITY OF SAFFORD'S MEMBERSHIP IN THE RURAL ARIZONA GROUP HEALTH TRUST

WHEREAS, City of Safford ("Safford") is currently a Participating Entity in the Rural Arizona Group Health Trust ("the Trust"); and

WHEREAS, the City has previously elected Trust membership for the period of July 01, 2018 through June 30, 2021; and

WHEREAS, the Trust's Board of Trustees ("the Trust Board") has offered a renewal membership to City of Safford commencing July 01, 2021; and

WHEREAS, the City of Safford wishes to accept the offer and renew its participation in the Trust for a 3-year Membership Period commencing July 01, 2021 and terminating June 30, 2024; and

WHEREAS, renewal of the City's membership in the Trust will serve the interest of the City and its employees by providing the vehicle through which the City's employees can obtain their health and medical benefits.

NOW, THEREFORE, IT IS RESOLVED AS FOLLOWS:


1. The Safford City Council hereby authorizes the renewal of the City's membership in the Trust for the period commencing July 01, 2021 and terminating June 30, 2024 and by doing so Safford agrees to be bound by the terms of the Declaration of Trust and the By Laws of the Trust.
2. The Safford City Council hereby appoints the following Trustee to serve on the Board of Trustees of the Rural Arizona Group Health Trust from July 01, 2021 until the appointment of a duly-qualified successor, consistent with the Trust's Declaration of Trust Agreement and By-Laws.

3. The Safford City Council hereby appoints the following Alternate Trustee to serve on the Board of Trustees of the Rural Arizona Group Health Trust from July 01, 2021 until the appointment of a duly-qualified successor, consistent with the Rural Arizona Group Health Trust Declaration of Trust and By-Laws;

Alternate Trustee: City Manager




