

RESOLUTION NO. 12-002

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF SAFFORD, GRAHAM COUNTY, ARIZONA AUTHORIZING THE CITY MANAGER TO SUBMIT AN APPLICATION TO THE STATE OF ARIZONA, DEPARTMENT OF TRANSPORTATION, FOR SURFACE TRANSPORTATION PROGRAM FUNDS FOR THE IMPROVEMENTS OF 20TH AVENUE FROM RELATION STREET TO GOLF COURSE ROAD.

WHEREAS, the City of Safford desires to make these improvements to 20th Avenue from Relation Street to Golf Course Road using City and State funds for the safety and benefit of the residents of Safford; and

WHEREAS, the Arizona Department of Transportation has requested applications for funding for their Surface Transportation Program (STP); and

WHEREAS, the City of Safford will provide the required funds (5.7% match) for the improvements along 20th Avenue; and

WHEREAS, the City of Safford will commit that these improvements needed will be completed no more than three (3) years after award of this funding from the State Transportation Board and the execution of the Joint Project Agreement; and,

WHEREAS, the City of Safford will commit to pay for all cost overruns or any cost not budgeted, if any, for these improvements; and,


WHEREAS, the City of Safford will commit to reimburse to ADOT/FHWA all federal funds used, if the project is canceled by the City; and,

WHEREAS, the City of Safford confirms that 20th Avenue is a functionally classified route and is on the SouthEastern Arizona Governments Organization's (SEAGO) approved list of routes.

WHEREAS, the improvements will reconstruct this street so as to widen, add curb and gutter, sidewalks, and other incidental or needed structures.


NOW THEREFORE, BE IT RESOLVED, by the Mayor and City Council of the City of Safford, Arizona does hereby authorize the City Manager to submit an application to the State of Arizona for Surface Transportation Program (STP) funds for the improvements along 20th Avenue from Relation Street to Golf Course Road.




