

RESOLUTION NUMBER 12-006

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF SAFFORD, GRAHAM COUNTY, ARIZONA AUTHORIZING THE CITY MANAGER TO SUBMIT AN APPLICATION TO THE STATE OF ARIZONA, DEPARTMENT OF TRANSPORTATION, FOR TRANSPORTATION ENHANCEMENT PROJECT FUNDS FOR THE CONSTRUCTION AND IMPROVEMENTS OF PHASE VII OF THE SHARED-USE PATH.

WHEREAS, the City of Safford desires to construct a shared-use path using City and Federal funds for the safety and benefit of the residents of Safford; and,

WHEREAS, the Arizona Department of Transportation has requested applications for funding for transportation enhancement projects; and,

WHEREAS, the City of Safford has sufficient City funds to provide at least the required funds for the shared-use path improvements and to maintain the completed path; and,

WHEREAS, the City of Safford will commit to a 5.7% match and any overmatch; and,

WHEREAS, the City of Safford will commit to funding the project scoping document, the environmental, the right of way and utility clearances, and the design of this project at the required match; and,

WHEREAS, the City of Safford will commit that the project will be ready for advertisement in 36 months from the Notice-to-Proceed; and,

WHEREAS, the City of Safford will commit to pay for all cost overruns; and,

WHEREAS, the City of Safford will commit to reimburse ADOT/FHWA for all federal funds used if the project is cancelled by the City of Safford; and,

WHEREAS, the City of Safford will commit to pay ADOT's review fees; and,

WHEREAS, the City of Safford will commit to a Joint Project Agreement with ADOT; and,

WHEREAS, the City of Safford will prepare an application for funding the Highline Canal from 14th Avenue to 20th Avenue segment of the City of Safford Path System and will be requesting federal funds not to exceed \$750,000 with the City's Matching funds not exceeding \$43,000.

NOW THEREFORE, BE IT RESOLVED, by the Mayor and City Council of the City of Safford, Graham County, Arizona that the City Manager is authorized to submit an application for funding to the State of Arizona, Department of Transportation, for federal funds not to exceed \$750,000 with City of Safford matching amount not to exceed \$43,000 for a

transportation enhancement project for the construction and improvement of Phase VII of the City of Safford's Shared-Use Pathways. The exact Resolution Number 12-006

amount of such funds will be established when the plans for the transportation enhancement project are completed.
