

RESOLUTION NUMBER 12-011

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF SAFFORD, GRAHAM COUNTY, ARIZONA, DECLARING AND ADOPTING THE RESULTS OF THE PRIMARY ELECTION HELD MARCH 13, 2012.

WHEREAS, the City of Safford, Graham County, Arizona did hold a Primary Election on the 13th day of March, 2012 for the nomination of a Mayor and three Councilmembers; and,

WHEREAS, the official election results have been presented to and have been canvassed by the Safford City Council; and,

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and City Council of the City of Safford, Graham County, Arizona, as follows:

Total number of ballots cast at said primary election, as shown by the poll list, was **1,160**.

The number of ballots to be verified was **5**, and that **2** ballots were ineligible.

The votes cast for the candidate for **mayor** were as follows:

It is hereby declared of record that **WYN "CHRIS" GIBBS**, candidate for mayor, did receive more than one-half of the total number of valid votes cast and is hereby issued a certificate of election.

It is hereby declared of record that **RICHARD ORTEGA, JIM HOWES and KENNETH MALLOQUE**, council member candidates, did receive more than one-half of the total number of valid votes cast and are hereby issued a certificate of election. The candidates issued this certificate of election shall be seated, Monday, June 11, 2012, in accordance with Arizona Law and subsequent to the General Election on May 15, 2012.

It is hereby noted that a General Election, May 15, 2012, was not necessary being all candidates did receive more than one-half of the total number of valid votes cast and are

hereby elected.
