The candidates issued this certificate of election shall be seated, Monday, June 11, 2012, in accordance with Arizona Law and subsequent to the General Election on May 15, 2012.

It is hereby noted that a General Election, May 15, 2012, was not necessary being all candidates did receive more than one-half of the total number of valid votes cast and are

hereby elected.
