

RESOLUTION NUMBER 13-033

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF SAFFORD, GRAHAM COUNTY, ARIZONA, AUTHORIZING THE MAYOR TO AMEND AN EXECUTED INTERGOVERNMENTAL AGREEMENT WITH THE STATE OF ARIZONA, THROUGH THE DEPARTMENT OF TRANSPORTATION, FOR THE DESIGN AND CONSTRUCTION OF PHASE VI OF THE MULTI-USE PATH ALONG 14 AVENUE-HIGHLINE CANAL & GRAVEYARD WASH TO US 191 STAGE VI, ADOT FILE NO.: IGA/JPA 10-138-I, AMENDMENT NO. ONE

WHEREAS, on June 10, 2011, the State of Arizona Department of Transportation, (“ADOT”) and the City of Safford entered into an Intergovernmental Agreement for the design and construction of a multi-use pathway along 14th Avenue – Highline Canal & Graveyard Wash to US 191 (the “Agreement”); and

WHEREAS, ADOT and the City desire to amend said Agreement to provide for additional funding from ADOT to the City for Design and Right-of-Way Acquisition; and,

WHEREAS, for such purpose, Amendment No. One to Intergovernmental Agreement between the State of Arizona and the City of Safford has been prepared,

NOW THEREFORE, BE IT RESOLVED, by the Mayor and City Council of the City of Safford, Arizona, that the Mayor is authorized to execute an intergovernmental agreement with the State of Arizona, Department of Transportation, AG Contract No.: P0012010004237; ADOT File No.: IGA/JPA 10-138I, for the construction of a Multi-Use Path along 14 Avenue-Highline Canal & Graveyard Wash to US 191; City’s Project Name: Copper Heights Phase VI SUP; (ADOT Project No.: SL 683 01C, 02D, 01R; SEAGO TIP No. SAF-TE-09).
