

RESOLUTION NUMBER 13-034

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF SAFFORD, GRAHAM COUNTY, ARIZONA, AUTHORIZING THE MAYOR TO AMEND AN EXECUTED INTERGOVERNMENTAL AGREEMENT WITH THE STATE OF ARIZONA, THROUGH THE DEPARTMENT OF TRANSPORTATION, FOR THE DESIGN AND CONSTRUCTION OF DOWNTOWN INTERSECTION IMPROVEMENTS, ADOT FILE NO.: IGA/JPA 11-039I, AMENDMENT NO. ONE

WHEREAS, on August 9, 2011, the State of Arizona Department of Transportation, (“ADOT”) and the City of Safford entered into an Intergovernmental Agreement for the design and construction of downtown intersection improvements (the “Agreement”); and

WHEREAS, ADOT and the City desire to amend said Agreement to provide for additional funding from ADOT to the City for Design and Construction; and,

WHEREAS, the City of Safford has sufficient City funds to provide at least the required funds for these improvements and to maintain the completed infrastructure; and,

WHEREAS, for such purpose, Amendment Number One to the Intergovernmental Agreement between the State of Arizona and the City of Safford has been prepared,

NOW THEREFORE, BE IT RESOLVED, by the Mayor and City Council of the City of Safford, Arizona, that the Mayor is authorized to execute an intergovernmental agreement with the State of Arizona, Department of Transportation (AG Contract No.: P001 2011 002010; ADOT File No.: IGA/JPA 11-039I) for the design and construction of decorative crosswalk, bump outs, landscaping, and other miscellaneous items along Main Street from 8th Avenue to Central Avenue; City’s Project Name: Main Street Improvements; (ADOT Project No.: TEA-SAF-0(206)A; TRACS No.: SL723 02D/01C; SEAGO TIP No. 2011-14). Total Federal Funds amount for this work is \$961,249 with a total City Match of \$64,303. The exact amount of such funds will be established when the construction for the transportation enhancement project is completed. If the final amount of the City of Safford matching amount exceeds the amount set forth above by an amount greater than \$15,000, the increase amount will be subject to City Council ratification.
